#### PLEASE NOTE:

- All references to the Charlotte Court House VA DMS10 switch are associated with CLLI code CCHSVAXADS0 and will not be repeated throughout the notice.
- All references to the Emporia VA DMS100 switch are associated with CLLI code EMPRVAXADS0 and will not be repeated throughout the notice.

# **Description of the Planned Network Change(s):**

The Verizon Charlotte Court House VA DMS10 switch, located at State Highways 47 & 40, Charlotte Court House, Charlotte, VA 23923, will be retired and removed from the Verizon network after all traffic served by this switch is migrated to the Emporia VA DMS100 switch, located at 107 Valley St. Emporia, VA 23847. All traffic to be migrated to the Emporia VA DMS100 switch includes, but is not limited to inter-LATA (ACCESS/FG-B-D/CLEC/IXC), wireless and paging traffic.

### **Description of Reasonably Foreseeable Impact(s) of the Planned Change(s):**

All carriers, including competitive local exchange carriers (CLECs), interexchange carriers (IXCs, IECs), wireless carriers, and paging carriers will need to provision new trunk groups to support direct end-office trunking to the Emporia VA DMS100 switch or have existing trunk groups to that switch augmented.

All ASRs for the Emporia VA DMS 100 must be received no later than **September 7, 2022** in order to provide sufficient time to migrate the traffic described above. Local Exchange Routing Guide (LERG) change effective dates will be posted prior to decommissioning of the Charlotte Court House VA DMS10 switch (**on or after November 1, 2022**). This will serve to guide interconnect re-routes of traffic for the NPA code currently served by the Charlotte Court House VA DMS10 switch to reflect the Emporia VA DMS100 switch as the new home switch. All trunks to the Emporia VA DMS100 switch must be in place prior to the decommissioning of the Charlotte Court House VA DMS10 switch. All ASRs for the Charlotte Court House VA DMS10 switch must carry a project code of **CCHSVAXARS0**.
