PLEASE NOTE:

- All references to the Scarsdale NY DMS switch are associated with CLLI code SCDLNYSRDS0 and will not be repeated throughout this notice.
- All references to the Pleasantville NY DMS switch are associated with CLLI code PSVLNYPVPSA and will not be repeated throughout this notice.

Description of the Planned Network Change(s):

The Verizon Scarsdale NY DMS switch, located at 1021 White Plains Road, Scarsdale, NY 10583, will be retired and removed from the network after all traffic served by this switch is migrated to the Verizon Pleasantville NY DMS switch, located at 465 Marble Avenue, Westchester, NY 10570. All traffic to be migrated includes, but is not limited to, Inter-LATA (ACCESS/FG-B-D/CLEC/IXC), wireless, and paging traffic.

Description of Reasonably Foreseeable Impact(s) of the Planned Change(s):

Competitive local exchange carriers (CLECs), interexchange carriers (IXCs, IECs), wireless carriers, and paging carriers will need to secure new trunk groups built to the Pleasantville NY DMS switch or have existing trunk groups to that switch augmented. Carriers that are code holders for access connectivity in the Scarsdale NY DMS switch will be required to reposition the codes to the Pleasantville NY DMS switch.

All ASRs for the Pleasantville DMS switch must be received no later than March 1, 2022 in order to provide sufficient time to migrate the traffic described above. These direct end office trunk (DEOT) interconnections will support traffic migration for the Scarsdale NY DMS switch prior to its eventual decommissioning. Local Exchange Routing Guide (LERG) change effective dates will be posted; prior to decommissioning of the Scarsdale NY DMS switch (on or after **April 1, 2022**). This will serve to guide interconnect re-routes of traffic for the six (6) native codes currently served by the Scarsdale NY DMS switch to reflect the Pleasantville NY DMS switch as the new home switch. All ASRs for the Pleasantville NY DMS switch must carry the project code of **SCDLNYSRDS0**.
