PLEASE NOTE:

- All references to the Dighton MA DMS10 switch are associated with CLLI code DGTNMAELDS0 and will not be repeated throughout this notice.
- All references to the Newton MA C20 switch are associated with CLLI code NWTNMAWAPS1 and will not be repeated throughout this notice.

Description of the Planned Network Change(s):

The Verizon Dighton MA DMS10 switch, located at 2075 Elm Street, Dighton, MA 02715, will be retired and removed from the network after all traffic served by this switch is migrated to the Verizon Newton MA C20 switch, located at 787 Washington Street, Newton, MA 02460. All traffic to be migrated includes, but is not limited to, Inter-LATA (ACCESS/FG-B-D/CLEC/IXC), wireless, and paging traffic.

Description of Reasonably Foreseeable Impact(s) of the Planned Change(s):

Competitive local exchange carriers (CLECs), interexchange carriers (IXCs, IECs), wireless carriers, and paging carriers will need to secure new trunk groups built to the Newton MA C20 switch or have existing trunk groups to that switch augmented. Carriers that are code holders for access connectivity in the Dighton MA DMS10 switch will be required to reposition the codes to the Newton MA C20 switch.

All ASRs for the Newton MA C20 switch must be received no later than November 15, 2022, to provide sufficient time to migrate the traffic described above. These direct end office trunk (DEOT) interconnections will support traffic migration for the Dighton MA DMS10 switch prior to its eventual decommissioning. Local Exchange Routing Guide (LERG) change effective dates will be posted prior to decommissioning of the Dighton MA DMS10 switch (**on or after January 3, 2023**). This will serve to guide interconnect re-routes of traffic for the one (1) native code currently served by the Dighton MA DMS10 switch to reflect the Newton MA C20 switch as the new home switch. All ASRs for the Newton MA C20 switch must carry the project code of DGTNMAELDS0.
