PLEASE NOTE:

- All references to the Dorchester, MA 5ESS switch are associated with CLI code DRCHMAADDS1 and will not be repeated throughout this notice.
- All references to the Newton, MA C20 switch are associated with CLI code NWTNMAWAPS1 and will not be repeated throughout this notice.

**Description of the Planned Network Change(s):**

The Verizon Dorchester, MA 5ESS switch, located at 175 Adams Street, Dorchester, MA 02122, will be retired and removed from the network after all traffic served by this switch is migrated to the Verizon Newton, MA C20 switch, located at 787 Washington Street, Newton, MA 02460. All traffic to be migrated includes, but is not limited to, Inter-LATA (ACCESS/FG-B-D/CLEC/IXC), wireless, and paging traffic.

**Description of Reasonably Foreseeable Impact(s) of the Planned Change(s):**

Competitive local exchange carriers (CLECs), interexchange carriers (IXCs, IECs), wireless carriers, and paging carriers will need to secure new trunk groups built to the Newton, MA C20 switch or have existing trunk groups to that switch augmented. Carriers that are code holders for access connectivity in the Dorchester, MA 5ESS switch will be required to reposition the codes to the Newton, MA C20 switch.

All ASRs for the Newton, MA C20 switch must be received no later than August 5, 2024, to provide sufficient time to migrate the traffic described above. These direct end office trunk (DEOT) interconnections will support traffic migration for the Dorchester, MA 5ESS switch prior to its eventual decommissioning. Local Exchange Routing Guide (LERG) change effective dates will be posted prior to decommissioning of the Dorchester, MA 5ESS switch (**on or after October 1, 2024**). This will serve to guide interconnect re-routes of traffic for the eleven (11) native codes currently served by the Dorchester, MA 5ESS switch to reflect the Newton, MA C20 switch as the new home switch. All ASRs for the Newton, MA C20 switch must carry the project code of DRCHMAADDS1.
