- All references to the Drummonds Corner VA EWSD switch are associated with CLLI code HMPNVADCDS0 and will not be repeated throughout the notice.
- All references to the Chinese Corner VA CS2K switch are associated with CLLI code VRBHVACCPS0 and will not be repeated throughout the notice.

Description of the Planned Network Change(s):

The Verizon Drummonds Corner VA EWSD switch, located at 11 Wythe Creek Road, Hampton, VA 23666, will be retired and removed from the Verizon network after all traffic served by this switch is migrated to the Verizon Chinese Corner VA CS2K switch, located at 221 Dorset Avenue, Virginia Beach, VA 23462. All traffic to be migrated to the Chinese Corner VA CS2K switch includes, but is not limited to, Inter-LATA (ACCESS/FG-B-D/CLEC IXC), wireless and paging traffic.

Description of Reasonably Foreseeable Impact(s) of the Planned Change(s):

All carriers, including competitive local exchange carriers (CLECs), Interexchange carriers (IXCs, IECs), wireless carriers, and paging carriers, will need to provision new trunk groups to support direct end office trunking to the Chinese Corner VA CS2K switch or have existing trunk groups to that switch augmented.

All ASRs for the Chinese Corner VA CS2K switch must be received no later than **January 18, 2025**, to provide sufficient time to migrate the traffic described above. Local Exchange Routing Guide (LERG) change effective dates will be posted prior to decommissioning of the Drummonds Corner VA EWSD switch (**on or after February 14, 2025**). This will serve to guide interconnect re-routes of traffic for the four (4) NPA codes currently served by the Drummonds Corner VA EWSD switch to reflect the Chinese Corner VA CS2K switch as the new home switch.
