The purpose of this Modification is to:

A. Add the CLINs below, as follows:

These changes provide a measure of specificity and flexibility required by federal customer agencies.

The first is a “One-time Competition CLIN” which will be a placeholder for one time credits at the point of task order competition. It is viewed as a means for carriers to identify one-time competition credits in a way that allows agency procurement staff to clearly identify and consider credits when evaluating price quotes.

The scope of the proposed “IT Schedule 70 CLIN (Excludes Voice & Data Service Plans)” is for any product or service related to an agency’s carrier services needs that are particular to that federal agency customer and not represented under this FSSI BPA, with the exception of replacing or duplicating any voice and data service plans. In addition, an agency may not alter the pooling plan mix by requesting voice or data plans that deviate from the pre-defined pooling plans that have been identified under the FSSI Wireless BPAs. However, agencies may request particular products or services that are not represented so long as they are within scope of carriers’ services and identified on the vendors’ IT Schedule 70. The CLINs presented in this proposed modification request must map back to the service offered by the vendors’ IT 70 Federal Supply Schedule contracts and assessed for allowability and price determination at the task order level at the time of competition. Further, if an agency requires multiple items to be drawn from the vendors’ IT Schedule 70 contracts to satisfy their needs, the carriers must clearly address each CLIN separately, and map each CLIN clearly to their IT Schedule 70 contract.

If there is a question in terms of scope, either the contracting officer or carrier can request a scope determination from the GSA FSSI Wireless Program team who will act as final intermediary in providing one.

B. These changes are hereby incorporated into the BPA through the revised “FINAL Rev_VerizonWireless_FSSI_Wireless_Pricing_Tables_Spreadsheet_Amendment 009”

C. All other terms and conditions remain unchanged.
