The purpose of this Modification is to reflect the following changes:

- 1. To invoke Special H Clause H.34 "Continuity of Services" (CoS) for a period of 24 months. CLIN pricing will be extended in order to extend the WITS 3 contract by an additional period of 24 months from the current contract end date of November 30, 2023 to November 30, 2025.
- 2. Contract references to a maximum period of 16 years and 1 day are now changed to a maximum period of 18 years and 1 day. Sections I.8.1 and H.1 are updated as follows:

I.8.1 FAR 52.217-9 Option to Extend the Term of the Contract (MAR 2000)

- (a) The government may extend the term of this contract by written notice to the contractor within 30 days of the expiration of the contract; provided that the government gives the contractor a preliminary written notice of its intent to extend at least 60 days before the contract expires. The preliminary notice does not commit the government to an extension.
- (b) If the government exercises this option, the extended contract shall be considered to include this option clause.
- (c) The total duration of this contract, including the exercise of any options under this clause, shall not exceed 18 years and 1 day. (End of clause)

H.1 TYPE and TERM OF CONTRACT

This contract is an indefinite delivery, indefinite quantity (IDIQ) type of contract with fixed unit prices. The initial term of this contract was a base period of four (4) years from the date of award with four (4) one (1) year option periods. The initial term was followed by a four- and one-half year extension period consisting of a base year of three (3) years, with one (1) one year option and one (1) six-month option periods. The first extension period was followed by a second extension period of three years, consisting of a base period of one (1) year and two (2) one (1) year options. The second extension period was followed by the government invoking the FAR 52.217-8, Option to Extend Services for 6 months. Invoked FAR 52.217-8 is followed by the government invoking Special H Clause H.34 "Continuity of Services" for a period of 24 months. The total term of the contract will not exceed 18 years and 1 day.

3. Except as provided herein, all prices, terms and conditions of the document referenced in Item 10A remain unchanged and in full force and effect.
