



DATA CENTER COLOCATION

1. RATES AND CHARGES

1.1 **Rates and Charges.** Customer will pay the monthly recurring charges (MRC) and non-recurring charges (NRC) for the Data Center Colocation for Advanced and Standard Data Centers, (individually, a Service) as set forth below. The MRCs represents existing standard capacity. If at the time Customer places an order for Service such capacity has been reduced, Verizon may at its sole discretion deny Customer's request for Service, including but not limited to Space and Power, or provide Customer with revised charges for such Service, including charges for any custom build out of Space that may be required to accommodate Customer's request. Verizon may change the MRCs for Space and Power on a once per calendar year basis. MRCs for Power are not discountable. At the end of the initial term, Customer will pay the MRCs and NRCs set forth below without the application of any discount for which Customer may be eligible per the terms of Customer's Agreement. MRCs will begin accruing on the Service Activation Date for each Service ordered, unless Customer has not provided Verizon with all information reasonably requested by Verizon for the provisioning of Services. If Customer fails to provide such information, Verizon reserves the right to begin charging monthly recurring charges any time after the thirtieth (30th) day following Customer's order.

1.2 **Data Center Colocation Rates and Charges.** The following rates and charges apply to Data Center Colocation:

1.2.1 **Monthly Recurring and Non-Recurring Charges.**

1.2.1.1 **Equipment Space Options.**

1.2.1.1.1 **Standard.** The following monthly recurring charges apply.

1.2.1.1.2 **Advanced.** The following monthly recurring and non-recurring charges apply based on the type of equipment and whether the equipment is caged or non-caged (on the open Data Center floor). Caged space installation charges are determined on an individual case basis (ICB).

1.2.1.2 Power Options. One standard power option may be used per cabinet. AC power components are not protected by an uninterruptible power supply (UPS). DC power components are protected by a UPS. ~~Where Technical Support (Hands-and-Eyes Support) is available at a Data Center (the service is also known as Remote Hands Support), Customers will need to Customer with the first 2 subscribe to the service in order to request support, minimum subscription is 3 hours per month provided at no charge. After the first two, and usage hours per month, a \$200 per hour charge applies for Hands-and-Eyes Support, are being calculated in 15-minute increments.~~

1.2.3. UPS Units. UPS Units or other related Customer Premise Equipment. Optional Customer Premise Equipment (CPE) can be ordered via a separate Customer premise Equipment contract.

1.2.2 Monthly recurring charges begin to accrue on the Service Activation Date applicable to each Data Center Colocation service, unless Customer has not provided Company with all information reasonably requested by Company for the provisioning of Data Center Colocation services. If Customer fails to provide Company with such information, monthly recurring charges begin to accrue on the thirtieth (30th) day following the date of Customer's execution of the Agreement or Customer's placement of a Service Order. Monthly recurring charges, after application of all discounts and credits, incurred by Customer for Data Center Colocation services shall contribute to the Annual Volume Commitment (AVC), specifically excluding: (i) Taxes, as defined in the General Terms and Conditions; (ii) charges for local access; (iii) charges for equipment (unless otherwise expressly stated in the Service Agreement or Service Attachment); (iv) charges incurred for goods or services where Company or Company affiliate acts as agent for Customer in its acquisition of goods or services; (v) non-recurring charges; (vi) "Governmental Charges" as defined in the General Terms and Conditions and (vii) other charges expressly excluded by the Service Attachment or the Service Agreement. Notwithstanding anything to the contrary in the Service Agreement, Company shall not waive, and Customer is liable for and obliged to pay, any standard installation and any other non-recurring charges for Data Center Colocation.
