1. **RATES AND CHARGES.** Customer will pay the rates and charges set forth below. All conference calls are rounded to the next higher full minute. Calculation of usage begins at the time the first participating caller connects to a conference call and ends when either the last participating caller in the conference call disconnects or the Conference Center Coordinator terminates the call. If the computed charge includes a fraction of a cent, the fraction is rounded to the nearest whole cent. All per minute rates are per bridge port. Where relevant, the VBS III rate plan applies, unless explicitly stated otherwise.

3. INTERNATIONAL AUDIO CONFERENCING RATES AND CHARGES

3.1 **Rates and Charges – International AC.** Calculation of usage begins at the connect time of the first called party and ends when either the last Participant in the conference call disconnects or the applicable conference operator terminates the call. If a computed charge includes a fraction of a UK pence, European cent, Hong Kong cent, Singapore cent, Japanese yen or Australia cent, the fraction is rounded up to the nearest whole pence, cent or yen, as applicable. All per-minute charges will be rounded up to the next full minute. All International AC charges not included in this Service Attachment will be charged at Verizon's then-current standard rates.

3.1.2 **Service Charges.** Customer shall pay the following rates for the applicable International AC Services, which rates are fixed for the Term of the Agreement. Except as expressly stated in this Service Attachment, no other discounts will apply to International AC. Customer will be responsible for all other rates and charges associated with International AC at the then prevailing standard rates and charges. International AC pricing is based on a per minute, per line rate for bridging and transport, based on service type and region, as set forth below. All references to prices below are in Australian Dollars, Hong Kong Dollars, Japanese Yen, Singapore Dollars, Pounds Sterling and/or European Euros. International AC will be invoiced in the designated currency and will be invoiced separately from usage occurring in other call centers. - 3.2 **Currency Conversion.** For purposes of determining the contribution of Audio Conferencing Charges billed in a currency other than U.S. dollars towards the AVC, Verizon will convert those Charges from the originally-billed currency to U.S. dollars using an average monthly currency exchange rate applied to the originally-billed currency Charges invoiced in the corresponding monthly period. If, at any time during the Term of the Agreement, any law, regulation or practice prohibits or significantly impedes Verizon's ability to accept non-U.S. currency (including, but not limited to, UK pound sterling, European Euros, Hong Kong dollars, Singapore Dollars, Japanese yen, or Australian dollars) in payment of its non-U.S. currency invoices, the parties will negotiate in good faith to find a mutually acceptable solution.
- 3.3 **Cancellation Charges.** An additional charge will apply for each pre-scheduled International AC session either cancelled by Customer within 30 minutes of the scheduled conference session time or during which there are fewer than two participating connections.
- 3.4 **Overbooking Charge.** An overbooking charge will apply to each unused pre-scheduled International AC connection after the first 50 unused connections per completed International audio conference.
