

METRO PRIVATE LINE

1. RATES AND CHARGES

- 1.1 Customer will pay the monthly recurring charges ("MRC") and non-recurring charges ("NRC") for Verizon's Metro Private Line ("MPL") Access Service, which are fixed for the Term of this Agreement at (a) the then-current rate at the time of the quote, if the quote is still valid when the circuit is ordered (i.e., within 45 days of the date the quote is provided), or (b), the rates as set forth in this document under Metro Private Line Access Service, based on the circuit order date, if the quote has expired.
